## Mandrake Resources Limited (formerly Bronson Group Limited) (ASX: MAN) – Reinstatement to Official Quotation

### Description

The suspension of trading in the securities of Mandrake Resources Limited (the 'Company') is expected to lift and the Company reinstated to official quotation at the commencement of trading on Wednesday, 14 August 2019 at 10 AM AEST, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. The Company raised \$4,527,838 pursuant to the offer under its replacement prospectus dated 21 May 2019 ('Prospectus') by the issue of 226,391,900 shares at an issue price of \$0.03 per share and 113,195,950 free attaching options exercisable at \$0.03 per option on or before 14 July 2022.
